

## **GENERAL AND PARTICULAR CONDITIONS**

### **1 ° THE REGISTRATION(INSRIPTION)**

Send the demand(request) of registration(inscription) in the office of L.P.M. Limp mail 440. 64600 - ANGLLET

In reception of your demand(request) of registration(inscription), L.P.M. will send a file containing the index card(form) N 1 inquiry which must have returned to us, the index card(form) 2 and 3 concerning price lists(rates) and information on the transport, the index card(form) 4 and 5 specifying dates and place of the stay as well as theoretical schedule of the training course.

The index card(form) N 6 on the trousseau will be sent to you after confirmation of the registration(inscription).

To confirm your choice and take into account your application(candidacy), will be required(demanded) 30 % of the amount of the stay by check, holiday vouchers or good C.A.F.à the order of L.P.M.

In reception of your demand(request), a confirmation of registration(inscription) will be sent to you .**Le pay(balance) must be paid(poured) at the latest, 10 days before the opening of the training course.**The association reserves the right to have without preliminary opinion(notice) of the place(square) of the candidate which would not have paid(poured) the totality for the deadlines(extensions).For safety reasons, the number of reserved persons can exceed(irritate) on no account the number of places.

### **2 ° THE CONDITIONS OF CANCELLATION**

- More than 45 days before the date of departure; 5 % of the total amount of the stay will be held(retained)
- Less than 45 days and more than 30 days before the date of departure; 25 % of the total amount of the stay will be held(retained).
- Less than 30 days and more than 7 days before the date of departure; 75 % of the total amount of the stay will be held(retained).
- In case of not presentation(display) in the date of the stay, no refund(repayment) will be made.

The prices(prizes) being fixed, will be granted no refund(repayment) for a late arrival, or a premature departure, except wound on the training course requiring a repatriation. The amount would be then in proportion to the effective duration of the stay.

The cancellation of a stay, for 30 Euro, possible rest in one of the following cases:

1. Serious illness, accident, grave wound or death(deaths) candidate or of a member(limb) of his(her) family.
2. Redundancy(D dismissal) of one of the relatives(parents).

### **3 ° THE REGULATIONS(PAYMENTS)**

L.P.M. accepts the regulations(payments) by postal, banking check, money order(mandate), transfer, holiday vouchers.

Payments by vouchers are possible after acceptance of the stay by your CIF which fixes the amount of the granted help.

L.P.M. can be on no account held responsible, if the announced amount is not in compliance with the real amount of the help paid(poured) after the stay. In that case or in the case of a refusal of CAF you will be then indebted at once of the balance of your stay.

### **4 ° THE RESPONSIBILITY**

L.P.M. cannot be held for responsible of the flights(thefts), the degradations and the deteriorations undergone on the properties(goods) belonging to the trainees.

It is advised(recommended) not to provide the children of valuables. L.P.M. can be engaged(opened) on no account in case of flight(theft).

The patent(certificate) of swimming is compulsory for the access for the aquatic pond. In the absence of this document at the time of the stay, L.P.M. will be capable of making cross(spend) this test(event) to the children.

### **5 ° THE INSURANCE(ASSURANCE)**

The association subscribed for all the persons present on the training course, an insurance policy covering all the activities which it organizes. Any incident or accident arisen during the stay is declared to the insurer.

### **6 ° MEDICAL EXPENSES**

In case of disease or accident L.P.M. advances(moves) the amount of so necessary medical expenses. At the end of the stay, those this are charged to the family which will receive, having settled the invoice, the corresponding medical claim form and can so ask for the refund(repayment) with the health insurance fund.

### **7 ° CONDITIONS OF WELCOME(RECEPTION)**

L.P.M. reserves the right to exclude a participant in the course of stay, without refund(repayment), nor compensations(allowances). This exceptional decision is taken in certain cases engrave(burn): incompatible attitude with the life in group, danger for the other participants, etc. ...

### **8 ° CANCELLATION OF the STAY BY PARTICIPANTS' INCAPACITY**

Until 21 days of the beginning of the training course (as attested by date on postmark) L.P.M. can cancel a stay if the number of participants was to be insufficient or still for inherent reasons instead of welcome(reception).

### **9 ° TRANSPORT**

The responsibility of L.P.M. begins from the opening of the training course Sunday from 3:00 am. However the participants who use the train are welcomed at the bus station of Uzerche where at the airport of Limoges for those who would use the plane. **This responsibility practices(is applied) only if L.P.M. was informed and arranges names and first names of the trainees arriving by the train where by the plane.** This coverage(care) stops dices the end of the training course on Saturdays as soon as possible has 10:00 am and dices the moment or the participants leave the surrounding wall(speaker) of the place of stay.

The accompaniment for return at the station where the airport is assured(insured).
